MHJA hasn't been using the XC jumps, they only use entry/pre-entry levels. Details to come when Danae is back from Tuscon. MHJA is looking for board members.

#### 8. 2015 Year Plans

a. April 19<sup>th</sup> Sarah Biron (Misty River) is hosting an INDOOR dressage show, day stalls available (night stalls if needed), some eventing tests if interested.

## b. Painting and Clean up day at BHP

Stadium jumps do not need to be painted this year by MHT. MHT does need to do a XC clean up. Tentative **May 2, 2015** course clean up.

- c. Ian Roberts clinic a possibility this spring.
- **d.** Willville August 7-9, 2015 Paige will double check.
- e. Dianne Clinic hosting June 19-20 (Tammy Ewing)- not confirmed, details to come.
- f. NHPC is running a lower level derby July 12, broad spectrum anyone can come as long as they meet the safety requirements and have paid a course user fee- paid to MHT (MHT members welcome). NHPC will charge a \$10 office fee, to be paid to MHT as the daily charge, for use of the course per rider/horse combo. All riders will need to have MHC insurance. Pony Club Insurance will cover NH and PC members for running the event and riding in the event. All non PC members will need to sign a Non PC Waiver form before riding.

#### g. Derbies:

- i. Derby 1 Date: May 30-31
  - 1. PC has their own dressage ring (GP ring) and show jumps in GP ring
  - 2. DW also has a show on
  - May 30<sup>th</sup>- PC meet the fences/clinic Danae? Dressage Coach required to cover the Dressage clinic on Sat and judge Sunday? Someone for Show Jumping in GP field. PC and MHT will have their own time slots to be on the xc course, at meet the fences. Time slots for Dressage and SJ tbd.
  - **4.** May 31- dressage, show jumping and xc event. Dressage and SJ of PC, XC run by MHT in field. Set times for everything.
  - **5.** Buy tickets, use the same tickets for PC and MHT. XC you pay MHT SJ or Dressage pay PC.
  - **6.** Geri will get the course ready for both Sat and Sunday. Jumps and course ready to go. Geri will also be the judge for XC Sunday.
    - a. No scoring as we're not adding XC, stadium and SJ marks together.
- ii. Derby 2 Date: June 27-28 (dressage test and derby each day)
  - 1. Danae will course design
  - 2. Training/ Prelim level will be included
  - **3.** DW show, we could stable and pay them like we're at a Dressage show and in the afternoon do the derby
  - **4.** MHT low to high and riders must tell DW they are riding with MHT as well, set times for each division.
  - **5.** No stadium (other than in the derby)

iii. Online registration form for derbies, to encourage people to pre-enter (\$30/day for horseshowtime.com)(Paige). Motion to enforce an entry closing date one week prior to the derby, otherwise double the fee. Motion: Jennifer Low McEleney, Second: Paige Dueck, Motion passed.
