Tests: Cadora – walk-trot through to 4<sup>th</sup> (available for free download at www.cadora.ca) EC tests can be ridden at a cost of an extra \$8 per test. One arena – groups of horses will have time to warm up and then individually ride tests. There is extra room in the arena for horses to stay between warm ups and tests.

Arena size: 20x40 for walk-trot and training , 20x60 first level through  $4^{th}$ . Western dressage classes: 20x60

MHC membership is compulsory. 2015 Membership # required on entry form. Visit: www.manitobahorsecouncil.ca for details.

Stabling available – \$25 for day stalls, a limited quantity of overnight stalls are also available. Please contact Misty River Ranch. biron@mistyriverranch.com

Entries due Wed 15<sup>th</sup> April. Late entries may be accepted if there is room, but will be charged a \$25 late fee and scheduled to ride on an ad hoc basis.

Timed order of go available Wednesday prior to the show which will be posted at barn and available in office and emailed to those who give an email address. The classes will run as per the list below. Cost: \$10 per class (\$18 for an EC test). No entries accepted without fully completed entry form, waiver and paid in full. Admin fee of \$25 per entry.

Attire: neat and tidy riding attire please, show jackets not compulsory but helmets are at all times whilst mounted. Western Dressage competitors: please note that helmets are required at all times whilst mounted. Turnout: braiding is not compulsory. Tack: appropriate for dressage. A tack inspector will be available to help you and offer friendly advice on the day.

Non-showing horses welcome; \$50 flat fee. Will have access to the arena during warm up periods. Excessively rowdy participants may be excused at the show committee's discretion. MHC membership, waivers, helmets and tidy attire are still required.

Freestyles: You do not need to have competed in a competitive test or group class in order to enter a Freestyle. No minimum % scores required. If you want to "test drive" a new floor plan or music, this is the time! Arena: 20x60m

Prizes: Highest score of the day in an individual class. Prizes to: Junior, AA, Open, Eventers, Pony Club members, Western Dressage Association members. To be eligible, this has to be declared, with current 2015 membership #, on the entry form.

## List of classes, timetable. We will PROBABLY run in this order, but the show committee retains the right to change or alter the order of go at their discretion:

Walk-Trots: Individually judged: Cadora tests A, B, EC tests 1,2,3

Dressage Equitation: group class, rider being judged. May be split according to rider age if sufficient entries.

Training Level: Cadora Tests A, B, EC 1,2,3

Road Hack: group class, some basic dressage movements may be asked for.

First Level: Cadora Tests A, B, EC 1,2,3

Eventing Tests: All levels from Pre-entry through Prelim

Show Hack: group class; some collection and extension may be asked for.

Second Level: Cadora Tests A, B, EC 1,2,3

Third Level: Cadora Tests A, B, EC 1,2,3

Fourth Level: Cadora Tests A, C, EC 1,2,3

Freestyles: level 1 through level 4, Cadora or EC.

English Pleasure: group class, judged on basic dressage way of going.

Western Dressage Tests: basic, through intro, level 1 to level 3 and freestyles.
