

Secretaries Report - February 10, 2025

1. Emailed Rob white back on January 20, 2025 asking what capacity he would like to help. Have not heard back

6. Review of Breezy Bend
 - a. They currently have every weekend date available aside from Saturday November 8
 - b. We need to submit an idea of what we would like and then they can do up pricing for us (ex if we would like light food or snacks for the AGM) I have attached their special events package for review
 - i. I personally don't think we need snacks/light food for the AGM as we never know how many people will be coming, i would think we would just need water - i am not sure how this will affect the pricing for the rental
 - ii. It's important to note that all prices are subject to 12% taxes and an 18% service fee
 - iii. If we are going to have the meal as a lunch again, the best priced option appears to be the pasta buffet which is what we had in 2024. It is \$36 per person and there is a 20 person minimum.
 - iv. If we are going to have a dinner, prices for plated dinners start at \$54 and go up to \$65
 - v. I think it may be worth it to send out a survey to the membership to see if they would prefer a lunch or a dinner, the AGM at the same time as the banquet or in online on a different day etc I have attached questions to be reviewed - this can be sent out to membership via google forms
